

# Freedom of Information Request - Reference 22-164

I refer to your application for access to government information received by Transport Canberra and City Services (TCCS) on 13 December 2022 under the *Freedom of Information Act 2016* (FOI Act). It is my understanding that you are seeking access to the following government information:

"...the subject line of all final ministerial briefs from 12 September to 12 November 2022 generated for or directed to any ACT Government Minister. This request includes, wherever possible, the date of the brief, the internal reference, position of authority it was written by, and which Minister it was addressed to. This request includes briefs prepared for Question Time, but not for Estimates or Annual Reports."

A decision was due on your access application by 13 January 2023. I thank you for agreeing to an extension until 30 January 2023.

# Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the FOI Act.

#### **Decision on access**

In accordance with the FOI Act, a search was conducted of records held by TCCS. A list of all relevant information has been compiled into a format consistent with your request.

In reviewing the information within these records, I have found, on balance, it is in the public interest to provide you with partial access. My decision is detailed further in the below statement of reasons.

#### **Statement of Reasons**

In making my decision on disclosing government information, I must identify all relevant factors in schedule 1 and 2 of the FOI Act and determine, on balance, where the public interest lies. In reaching my access decision, I have taken the following into account:

# Schedule 1

• No relevant factors identified

# Factors favouring disclosure in the public interest (Schedule 2.1)

- Schedule 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability;
- Schedule 2.1(a)(ii) contribute to positive and informed debate on important issues or matters of public interest; and
- Schedule 2.1(a)(iii) inform the community of the government's operations, including the policies, guidelines and codes of conduct followed by the government in its dealings with members of the community.

# Factors favouring non-disclosure (Schedule 2.2)

- Schedule 2.2(a)(xi) prejudice trade secrets, business affairs or research of an agency or person;
- Schedule 2.2(a)(xiii) Prejudice the competitive commercial activities of an agency.

In reviewing the information with the scope of this application, one subject line has been identified as containing information relating the business affairs of a third party. This information relates to the financial planning of that third party and is likely to prejudice their business affairs if disclosed. I have also considered that this information has been provided to TCCS with an expectation of confidentiality, and disclosure is likely to prejudice future commercial activities. I have placed significant weight on these factors and find that disclosure is, on balance, contrary to the public interest.

I have found that the factors favouring disclosure can be satisfied with the deletion of information which is contrary to the public interest. A copy of the relevant information is enclosed at <u>Attachment A</u>.

# Charges

No fees are applicable as the total number of pages are within the fee-free threshold.

# **Online publishing – disclosure log**

# **Ombudsman review**
