#### Timeframes

TCCS is required to decide on your application by 11 April 2023.

#### Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the FOI Act.

#### **Decision on access**

In accordance with the FOI Act, a search of records held by TCCS, and the office of Minister Steel, has been completed and 14 records have been identified as relevant to your application.

Upon reviewing the information within the records and applying the public interest test under section 17 of the FOI Act, I have decided to provide you with partial release of these records.

#### Statement of Reasons

In reaching my access decision, I have taken the following into account:

- The FOI Act; and
- The Human Rights Act 2016.

In making my decision on disclosing the relevant government information, I must identify all relevant factors in schedule 1 and 2 of the FOI Act and determine, on balance, where the public interest lies.

#### Schedule 1:

## Schedule 2:

#### Factors favouring disclosure in the public interest (Section 2.1)

- Section 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability; and
- Section 2.1(a)(viii) reveal the reason for a government decision and any background or contextual information that informed the decision.

### Factors favouring non-disclosure (Section 2.2)

• Section 2.2(a)(ii) - prejudice the protection of an individual's right to privacy or any other right under the Human Rights Act 2016.

In reviewing the relevant records, personal information relating to third parties, including information which is likely to identify a third party, has been identified. This includes the names and contact details for all external parties, including any complainants. I have considered that this information is not readily available to the public and the disclosure of this information is likely to prejudice the protection of an individual's right to privacy under the Human Rights Act 2004 and carries significant weight. In this instance, I have found the disclosure of personal information to be, on balance, contrary to the public interest.

I have found that the factors favouring disclosure can be satisfied with the deletion of information which is contrary to the public interest. A copy of the relevant information is enclosed at <u>Attachment B</u>.

#### Charges

In accordance with <u>Freedom of Information (Fees) Determination 2018</u>, a fee of \$0.35 per page of information disclosed, except for the first 50 pages, may be applied to an access application. The total number of pages in your application does not exceed the fee-free threshold.

#### **Online publishing – disclosure log**

Under section 28 of the Act, TCCS maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents will be published in the TCCS disclosure log between 3 – 10 business days from the date of this decision. Your personal contact details will not be published. You may view the TCCS' disclosure log here.

### **Ombudsman review**

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek an Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in TCCS' disclosure log, or a longer period allowed by the Ombudsman.

### Background

- 1. A motion was raised in the Legislative Assembly on 30 November 2021 regarding the use and management of informal use (dryland) ovals (<u>Attachment A</u>).
- 2. Dryland ovals are non-irrigated ovals that can be used by the community for informal recreation. Sport and Recreation (City Presentation) is the custodian of these ovals.
- 3. The use and management of informal use (dryland) ovals is addressed in the Land Management Plans, which are currently being reviewed and consolidated. It is anticipated that a draft Urban Open Space Land Management Plan (the draft Plan) will be ready for public consultation later this year.

#### Issues

- 4. The motion calls on the ACT Government to: undertake public consultation on the draft revised Land Management Plan (including on dryland ovals); finalise the Plan based on community feedback; engage with community groups to identify potential uses of dryland ovals as part of the Adopt-a-Park initiative; consult with the Florey Primary School and community regarding community uses of the Florey oval; and report on progress to the Assembly by the first sitting week in 2023 (<u>Attachment A</u>).
- 5. The draft Plan will detail how the different types of urban open spaces and their associated facilities are used and managed.
- Once the draft Plan is approved by you, it will be released for public consultation.
   Feedback received by the community on the draft Plan during the consultation period will be considered and incorporated into the final Plan where appropriate.
- 7. It is anticipated that, whilst the draft Plan will list the range of acceptable community use options for dryland ovals, it will also note that there may be other strategic uses identified by other parts of Government (such as a needs-based decision to invest to return dryland ovals to fully functional sportsgrounds). TCCS will commit to investigate the framework for activating dryland ovals as an explicit action in the draft Plan that will engage government and the community.
- 8. The Adopt-a-Park Community Grants Program may provide opportunities for local communities to improve the amenity and use of dryland ovals through projects such as nature play, weed control, tree planting and community events.
- 9. The Florey community have been liaising with Florey Primary School about the future use of Florey oval adjacent to the school. The oval is currently used by the school and the community have raised some potential shared uses of the space. The Education Directorate is leading community consultation in relation to this matter, and TCCS has offered to assist wherever necessary.
- An additional matter has since been raised regarding the 'rewilding' of informal use (dryland) ovals. TCCS will discuss this and other proposed alternative uses, in the draft Plan.

12. Consultation with other business units within TCCS (Sport and Recreation, City Presentation) has been undertaken.

#### Cross Directorate

- 13. No direct consultation has been undertaken with other Directorates. The Education Directorate is leading community consultation regarding the shared use of Florey oval between Florey Primary School and the Florey community.
- 14. As mentioned above, this matter has been discussed briefly with staff from Partnerships and Planning, Sport and Recreation (CMTEDD).

#### **External**

- 15. Public consultation on the draft Plan will be undertaken once it is completed and approved for release.
- 16. The Minister for Sport and Recreation will also be consulted.

## Work Health and Safety

- 17. Public safety is taken into consideration as a priority when determining the use and management of all open spaces owned by TCCS, including informal use (dryland) ovals.
- 18. Adopt-a-Park volunteer groups undertake induction and WHS training prior to commencing project works on public land.

#### **Benefits/Sensitivities**

- 19. The Belconnen conservation/ environment stakeholders may continue to raise the matter of 'rewilding' dryland ovals in the Belconnen region, in particular Fernhill Park in Bruce and Macquarie Oval.
- 20. There are potentially competing uses of informal use (dryland) ovals, such as informal recreation, dog off-leash areas, tree planting, the possible full or partial re-instatement of irrigated areas for formal sports, etc. These are reviewed on a case-by-case basis.

#### Communications, media and engagement implications

21. Once the draft revised Land Management Plan is approved by you to be released for public consultation, a draft media release will be prepared for your consideration.

# Sport and recreation—dryland ovals

#### MS CLAY (Ginninderra) (4.16): I move:

That this Assembly:

- (1) notes that:
  - (a) the ACT has 31 dryland ovals, including 14 in the Belconnen region and these make up a significant part of our outdoor community space;
  - (b) climate change is leading to a hotter, drier Canberra climate;
  - (c) these 31 dryland ovals were converted from irrigated sports fields due to the millennium drought, the cost of irrigation and the increasing amount of water needed to upkeep these sports fields;
  - (d) the cost to convert a dryland oval back into an irrigated sports field is more than one million dollars and the upkeep on these fields is considerable;
  - (e) dryland ovals are now first and foremost informal sporting and recreation spaces available to use for the whole community;
  - (f) dryland ovals are a community resource that are currently underutilised and residents near these ovals would like a better use of this large amount of local community space;
  - (g) ACT Government values dryland ovals as a community and recreational space, and wants to preserve them as publicly-owned green spaces;
  - (h) local communities provide valuable feedback about what is in and around their suburbs, and should play an active role in the development of their suburb;
  - (i) some communities are already well advanced in discussions with ACT government about the future of their dryland oval, such as the Florey community who have been engaging with the Florey Primary School over the past year; and
  - (j) community members have suggested many low-cost climate resilient ways that dryland ovals could be repurposed for community use, including but not limited to:
    - (i) community-constructed BMX dirt bike tracks;
    - (ii) nature playgrounds;
    - (iii) community run micro-forests or urban rewilding projects;
    - (iv) adventure playgrounds;
    - (v) enclosed dog off-leash areas;
    - (vi) community gardens;
    - (vii) outdoor exercise areas; and
    - (viii) disc golf courses;

- (2) further notes that the ACT Government:
  - (a) recently released a draft Play Space Strategy and is currently consulting on this;
  - (b) is due to commence a review of Public Land Management Plans for urban open spaces, including dryland ovals, in 2022; and
  - (c) has an Adopt-a-Park program, which provides grants funding to support community-led initiatives on urban open area land including micro-forests; and
- (3) calls on the ACT Government to:
  - (a) conduct public consultation on land management plans for urban open spaces with the local community, including on the 31 dryland ovals, with residents, local Parent & Citizen groups, local businesses and local community groups;
  - (b) finalise updated land management plans, which will include specific consideration of dryland ovals and incorporate the feedback and aspirations on their future use received from the local community;
  - (c) promote the Adopt-a-Park initiative and engage closely with community groups wanting to start projects to improve dryland ovals and other open spaces for community uses;
  - (d) continue to work with the Florey Primary School and the community on commitments to improve the Florey oval to provide more active open space for the school and local community; and
  - (e) report back to the Assembly on progress on this motion by the first sitting week in 2023.

My motion concerns "dryland ovals", which may not be a term everyone immediately recognises. Canberra has plenty of dryland ovals. We have 31 in total, and 14 of those are in Belconnen. That is why I brought this motion, and I am sure it will be of particular interest to my MLA colleagues in Ginninderra.

We have all heard from constituents about our local dryland ovals. Community members write in and stop me at stalls with questions all the time. They have so many great ideas, and it made me realise how important it is to get feedback from people about their local areas. That is why I have put community consultation at the heart of this motion. A lot of people wonder why their ovals are in the condition they are in. Especially if you are new to Canberra, you may not realise that these ovals were converted from irrigated sports fields to the dryland condition they are in today. I have lived in Belconnen my whole life and I remember the difficult decision taken during the millennium drought. I also understand that decision.

We chose to keep some irrigated sports fields—that is important; we need to keep some for structured sport—but we reduced the number of irrigated ovals in Canberra. We simply could not afford the water. I will start with the environmental cost. We are in a climate crisis. Canberra is getting hotter and drier, with more extreme weather. Some years we have a lot of rain—this year is one of them—and our dams are full. But we all know this will not last forever, and the trend is towards a hotter and drier

Hi Steel Team,

Following up from the Dryland ovals motion last year we're hoping to find out what is going on with the Urban Open Space Management Plan consultation – including the specific consideration of dryland ovals under the plan.

We are also wondering where the Florey-specific dryland oval consultation is up to, noting we have heard the school is only consulting with the school community on the portion of oval that the school will eventually use.

Given previous comments that the consultation would be completed by July we're just hoping that this timeline will be extended rather than consultation skipped, and that a YourSay or similar survey will be provided for the community to get involved.

MS CLAY: To ask the Minister for Sport and Recreation-

- (1) Can the Minister provide an update on the progress of consultation with the Florey school community, and broader Florey community on the future of their dryland oval.
- (2) Can the Minister provide a timeline for this consultation.

MS BERRY MLA - The answer to the Member's question is as follows:

- (1) Transport Canberra and City Services (TCCS) as the land custodian has been collaboratively working with the Education Directorate to determine opportunities for the Florey dryland oval. The Education Directorate has been working with the school to gather ideas for a suitable open space for the students on a portion of the oval site, which would also improve local recreation facilities. The ACT COVID-19 lockdown delayed any further engagement work planned by the Education Directorate in 2021. Indicative sketches have been developed and will form the basis for the next phase of consultation.
- (2) TCCS is currently reviewing the existing land management plans for public unleased land, which includes dryland ovals. As part of that review, consideration will be given to the future management of dryland ovals. The review will result in a single land management plan which is anticipated to be released as a draft for public comment in mid-2022. With regard to Florey Oval, the Education Directorate met with the school Principal in April 2022 to recommence communication and

engagement activities. # FLOREY DRYLAND OVAL REFRESH

# **REPORT ON WHAT WE HEARD**

Canberrans were invited to have their say on the redevelopment of a portion of the Florey Dryland Oval from 27 July to 7 September 2022. The redevelopment will help create a natural outdoor space for students at Florey Primary School, who use this space every day, and the wider community for recreational use in the evenings and weekends.

Student ideas and input will also inform plans for this exciting new shared school and community space.

The redeveloped portion of the oval will become an educational and engaging space for students to access and enjoy every day as part of their learning.

Outside of school hours this public space will allow community to relax, exercise, meet, play, chat and connect.

The Education Directorate is working closely with Transport Canberra and City Services on this project and feedback received through this engagement will help shape future plans for the wider oval.

# THE CONVERSATION

# Student and school community engagement

In 2019 Florey Primary School students provided early ideas and sketches into what they would like to see the oval become.

During the engagement period the Florey Primary School Leadership Team and Parents and Citizens (P&C) were engaged to help shape and promote engagement opportunities through school newsletters, online, at meetings, and to gather student input.

Every class from the school had the opportunity to vote on the elements they wanted to see as part of the redevelopment. 782 student votes were received through this process.

#### **Online survey**

An online survey, via the YourSay website, was open during the consultation period for the community to provide feedback. A total of 58 surveys were completed. The community was also invited to provide feedback via email and Facebook.





#### **Community pop-ups**

Two pop-up sessions were held during the consultation period onsite at Florey Primary School, and at the local shops on 17 and 22 August 2022 to provide the community with an opportunity to ask questions.

The Education Directorate was also invited to present to the Belconnen Community Council via its online meeting on 16 August 2022. We spoke to over 50 people across these sessions.

# WHO WE ENGAGED

The consultation targeted students, families and staff from the Florey Primary School, Florey locals as well as residents from the broader Belconnen region.

We promoted the consultation via:

- a letterbox drop to 1200 homes in the suburb of Florey
- the Belconnen Our Canberra print newsletter and electronic newsletter
- ACT Government, Education Directorate and Florey Primary School social media accounts
- Education Directorate and Florey Primary School websites
- Florey Primary School newsletter and P&C meeting
- an email to key stakeholders including the Belconnen Community Council.

98.3% of survey respondents were from the Belconnen region. Residents with the majority of other responses from neighbouring suburbs were located centrally (1.72%).

# WHAT WE HEARD

#### Key insights from the community

#### What is important to the students at Florey Primary School

- 1. There is strong support from students to see bubblers (drinking fountains) included in the redevelopment (135 votes)
- 2. The next most supported elements were recreational, with students wanting to see a bike track built (86 votes), closely followed by goal posts (81 votes)
- Picnic tables were equal third in students votes, alongside a nature and imaginative play space (73 votes each)
- 4. We also heard from students would like to see shaded areas incorporated in this space
- 5. Access to the oval and safety is important to the school leadership, ensuring every student benefits from this refreshed space.



# What is important to the Florey (and wider Belconnen) community

- 1. There is strong support from community for nature and imaginative play spaces, shaded areas, and seating
- 2. Open irrigated greenspace followed by trees are also of high priority for community
- 3. Safety and access to the oval is important to ensure everyone benefits from this refreshed space.

#### How community currently use the oval

- 1. 65% of respondents told us they were already frequent users of the oval
- 2. 47% of respondents currently use the oval to walk and exercise their dogs
- 3. 22% currently use the oval to exercise
- 4. While some respondents didn't currently use the oval, they said they would do so once the space was redeveloped.

#### Community priorities for the oval

- 1. It is important for community that the redevelopment of the area prioritises the benefits to Florey Primary School students first, followed by community use in the evenings and weekends
- 2. The community sees this initial redevelopment as just the beginning for this project. Respondents said they would love to see the entire oval redeveloped over time

# WHAT'S NEXT?

Feedback from this engagement will help shape the final design for the first portion of the Florey dryland oval. We look forward to sharing the design with you later this year.

# **Directorate's Response**

## Background

• Minister for Education met with Florey Primary School March 2021 and discussed ideas about a refresh for a portion of the Florey oval with students.

• In June 2021, Minister for Education met with Florey P&C to present and gather feedback and ideas from parents about the oval's refresh.

- During 2021 an engagement plan was developed to guide the community engagement process inclusive of stakeholder engagement.
- Transport Canberra and City Services (TCCS) Directorate as the land custodian are collaboratively working with the Education Directorate in relation to the intention to refresh a portion on the oval.

• October 2021 – TCCS reported the priority for Florey Oval is to provide adequate green space for use by the Florey Primary School. While the Education Directorate and TCCS are working collaboratively to identify possible solutions, no specific plans have been developed nor funding provided.

• May 2022 - Education Directorate met with Florey Primary School Leadership team, Board and P&C. Discussions to commence community engagement and a YourSay campaign were confirmed at this meeting.

• July 2022 - Commencement of the initial six-week YourSay community engagement to gather feedback to inform this oval refresh.

• The priority for the Minister for Education and Youth Affairs, is for improved access to a suitable outdoor open space for students at Florey Primary School that can also be used by the Florey Community outside of school hours.

• On closing of community comments through the YourSay engagement, feedback will be collated and shared with TCCS. Particularly any input that considers the remaining oval areas beyond the focus of the Education Directorate.

• Before committing to further actions beyond the initial portion of the oval that Education will refresh, input from YourSay will be considered.

• While TCCS and the Education Directorate are working collaboratively on considerations for the Florey Oval refresh, the immediate priority is delivering additional outdoor learning and green space for Florey Primary School students.

• The Education Directorate will lead and fund the design and implementation of the portion of the oval refresh. Design for further upgrades to the remainder portion of the oval will be lead by TCCS and subject to future funding.

Florey Community Action held an informal community consultation morning at Florey Oval on Sunday 20 March 2022. It was decided to provide residents with the opportunity to start to express their ideas regarding the motion passed in the ACT Legislative Assembly in December on dryland ovals with Florey Oval being the first oval to be considered.

Florey Primary School was consulted in late 2021. Florey Community Action community consultation was arranged to start of the process from a resident's perspective as many were concerned about the lack of consultation and progress following on from the consultation with the school.

#### Florey Community Action Meeting Outcomes, 20 March 2022

#### Consensus

- A portion of Florey Oval needs to be maintained and a perimeter established (either fence or clear boundary, e.g., plantings) for use by the Florey Primary School. There were varying views on how much and how this could be quarantined, including the need to maintain and improve access from the northern part of Florey to the shopping precinct for pedestrians and other vulnerable road users.
- A suggested way forward is for the Florey Oval dryland oval work to be managed under the umbrella of the ACT Wellbeing Framework.

#### **Concerns Raised by Residents**

- One resident has enrolled their child to a school outside Florey due to the lack of outdoor sporting area at Florey Primary School.
- What has happened to the consultation that was done in the school?
- General tidying and maintenance of the Florey Oval and surrounds blocked and overgrown drain; drainage in general is inadequate.
- Access to portioned off area for school, including hearing bells, the in-between spaces.
- Need for access for general public when not in use by school.
- One attendee wanted to put forward a view that no changes were needed.

#### **Community Suggestions for Non-School Area**

- Community vegetable gardens.
- Nature play area examples given were Hughes, Denmark.
- Mixed parks for different purposes.
- Amphitheatre opportunities for outdoor school assemblies as well as community use for such things as musical performances outside of school hours.
- Outdoor learning environment (in addition to the maintained portion).
- Seating and picnic tables in surrounding areas.
- Bicycle path/jumps something that is between the toddler bike space at Lake Ginninderra and the formal BMX tracks in Melba.
- Outdoor basketball/netball court for public use.
- Exercise stations like at John Knight Park.

- Reduced scale frisbee golf.
- Dog park for residents without use of cars.
- Bins and dog poop bags.
- Artwork/sculptures.

#### **Issues Related to Florey Oval Redevelopment**

- Strategic approach to future changing demographic of Florey and nearby suburbs broader plan for the precinct, not just the oval.
- Road access needs revision including direct access into the car park area adjacent to Florey Oval from John Cleland Crescent.
- Placement of toilets for Florey shops.
- Harvesting water from school roofs for irrigation.
- Funding of the maintained portion of the oval concerns about impact on school budget.

#### Way Forward from Florey Community Action Perspective

- 1. Community forum involving Florey Primary School and Florey residents to be organised in the next three months. ACT Government to organise and promote the community forum.
- 2. ACT Government to provide information about the ACT directorate managing the project
- 3. ACT Government to ensure its redevelopment takes into consideration the election. commitment of toilets at Florey Shops and traffic issues raised around the Florey Shops.
- 4. ACT Government provide timelines regarding its redevelopment.

This letter is really good news, but it doesn't match up with what we heard at last night's BelcoCouncil. We had a lovely presentation by John Nakkan, but we were told pretty clearly that the consult is only looking at the 1/3 of the oval which is going to be used by the school & delivered by Education. John said the consult and design will not plan out the remaining 2/3 of the oval. He thought that would be delivered by TCCS separately at another time but couldn't say.

I've had members of the Florey community raise this with me as a significant concern. They want the project to be consulted on and planned together as an integrated whole, to make sure the whole space is useful, works together and doesn't duplicate ideas. They don't want the school bit done separately, and in isolation from the rest of the space.

Also noting the words of the original Assembly motion, we've agreed that government will - "Continue to work with the Florey Primary School and the community on commitments to improve the Florey Oval to provide more active open space for the school and local community" – it's clearly about the school AND community and the school space AND community space, not just one section or the other.

Are Education and TCCS both working on this together? Will the consult pick up the entirety of the dryland oval space? Will the whole space be designed and planned at the same time and as one integrated project, even if different bits are delivered at different times?
