Freedom of Information Request – 18-075

I refer to your application made under the *Freedom of Information Act 2016 (the Act)* received by Transport Canberra and City Services (TCCS) on 29 August 2018 in which access is sought to:

- documents and briefing notes prepared for the building of the Weston Creek Dog Park, including all tender documents, the scope of works, and documents relating to the delays in completing these works.

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

TCCS was required to provide a decision on your access application by 26 September 2018. I note that your office has agreed to an extension until 20 November 2018.

Decision on access

Consultation with third parties in relation to the reports identified that fall within scope to your request has now been completed. I note that your office has been contacted to confirm that tender submissions do not form part of the scope of this request. Tender details, quotations and tender evaluation reports have been identified.

A search of TCCS records was conducted and 61 documents (573 pages) were identified that fall within the scope of your request.

I have included as Attachment A to this decision the schedule of relevant documents. This provides a description of each document that falls within the scope of your request and the access decision for each of those documents.

I have decided to grant full access to documents referenced 2, 4-6, 10-14, 16-20, 24-25, 34, 46-51, 53 and 60.

I have decided to grant partial access to documents referenced 1, 3, 7-9, 15, 21-23, 26-33, 35-45, 52, 54-59 and 61 under section 50 of the Act, with deletions applied to information that I consider would be contrary to the public interest to disclose under the test set out in section 17 of the Act.

Statement of Reasons

In reaching my access decision, I have taken the following into account:

Factors favouring disclosure (Schedule 2)

- Section 2.1 (a)(viii) – reveal the reason for a government decision and any background or contextual information that informed the decision.

Factors favouring non-disclosure (Schedule 2)

- Section 2.2 (a)(ii) – prejudice the Protection of an Individual's Right to Privacy; and
- Section 2.2 (a)(xi) – prejudice trade secrets, business affairs or research of an agency or persons.

Documents referenced number 7-8, 31, 33, 35-40, 42, 54 consist of commercial information of third parties. The information includes quotations for works in relation to the Weston Creek dog park and tender evaluation reports which includes information about the tenderer's submission.

These documents contain information of commercial value and would, or could reasonably be expected, to be destroyed or diminished if the information were disclosed. The breakdown of costs for works holds commercial value which could be used by competitors. It is a fine balance to seek transparency in information release and protect against information being used to the commercial disadvantage of a third-party tender or contractor.

Furthermore, disclosure of this information could be expected to prejudice the future supply of information to TCCS for this purpose. Receiving detailed information from third parties who specialise in this field requires a level of trust that the detailed information will be used as indicated and that providers will not be exposed to adverse outcomes if the information is not protected. In this case, the release of any commercial information at this time would be damaging for the reasons I have discussed and outweighs the release in this instance.

Documents referenced 1, 3, 7-8, 15, 21-23, 26-33, 35-45, 57-59, and 61 of the identified documents contain personal information of third-party contractors and the mobile numbers of TCCS employees. Disclosure of personal information is governed by the 'use and disclosure' privacy principles. Part 3 of the Information Privacy Act 2014 (TTP 6.1) states that an agency that holds personal information about an individual that has been collected for a particular purpose, must not disclose the information to a third party unless the individual has consented to the use or disclosure of the information.

In considering the type of information I propose to withhold from release, I am satisfied that the factors in favour of release can still be met while protecting the personal information of individuals involved. I find the protection of this information outweighs disclosure in this instance. I have, therefore, decided that it is not in the public interest to disclose information that is considered as personal information.

Charges

The first 50 pages of a release of information are provided free of charge. Your request has exceeded the threshold of 50 pages. The number of pages is 573 pages. The charge for your FOI request is \$183.05. I am required to waive these fees under section 107 of the Act as you are a Member of the Legislative Assembly.

Online publishing – disclosure log

Under section 28 of the Act, TCCS maintains an online record of access applications called a disclosure log. Your original access application and my decision in response to your access application will be published in the TCCS disclosure log from 3 days after the date of this decision. Your personal details will not be published.

As the documents consists of commercially sensitive information it will not be published online. You may view TCCS' disclosure log at www.tccs.act.gov.au/about-us/freedom_of_information.

Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek an Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in TCCS' disclosure log or a longer period allowed by the Ombudsman.
