Freedom of information request: Reference 20-045

I refer to an access application made under the *Freedom of Information Act 2016* (the FOI Act) by you and received by Transport Canberra and City Services directorate (TCCS) on 17 June 2020. In your application, you requested access to the usage numbers for bus stop 1059 in Soward Way Greenway - either embarking or disembarking - for the financial years 2017/2018, 2018/2019 and 2019/2020.

I am an Information Officer appointed by the Director-General under section 18 of the FOI Act to deal with access applications made under Part 5 of the FOI Act.

Thank you for agreeing to an extension on you application until 12 August 2020.

Decision on access

A search of our electronic data management systems has identified data relevant to your request. This data has been exported into a PDF and is enclosed with this notice. I have decided to provide you with full access to this record. My reasoning is explained further below in the statement of reasons.

Statement of reasons

In reaching my access decision, I have taken the following into account:

Factors favouring disclosure in the public interest (Schedule 2.1)

- 2.2(a)(ii) - contribute to positive and informed debate on important issues or matters of public interest; and
- 2.2(a)(xvi) - contribute to innovation and the facilitation of research.

There were no factors favouring non-disclosure identified as relevant to the information being released to you and accordingly, the disclosure of these documents is in the public interest.

Charges

No fee is payable as the total number of pages (1) is within the fee free threshold.

Online publishing – disclosure log

Under section 28 of the Act, TCCS maintains an online record of access applications called a disclosure log. Your access application, this notice of decision and enclosed document will be published on the disclosure log within 3 – 10 business days. Your personal information will be removed from these documents before publication.

Ombudsman review

My decision on your access request is a reviewable decision under section 73 of the Act within 20 working days from the day that my decision is published in TCCS' disclosure log, or a longer period allowed by the Ombudsman.
