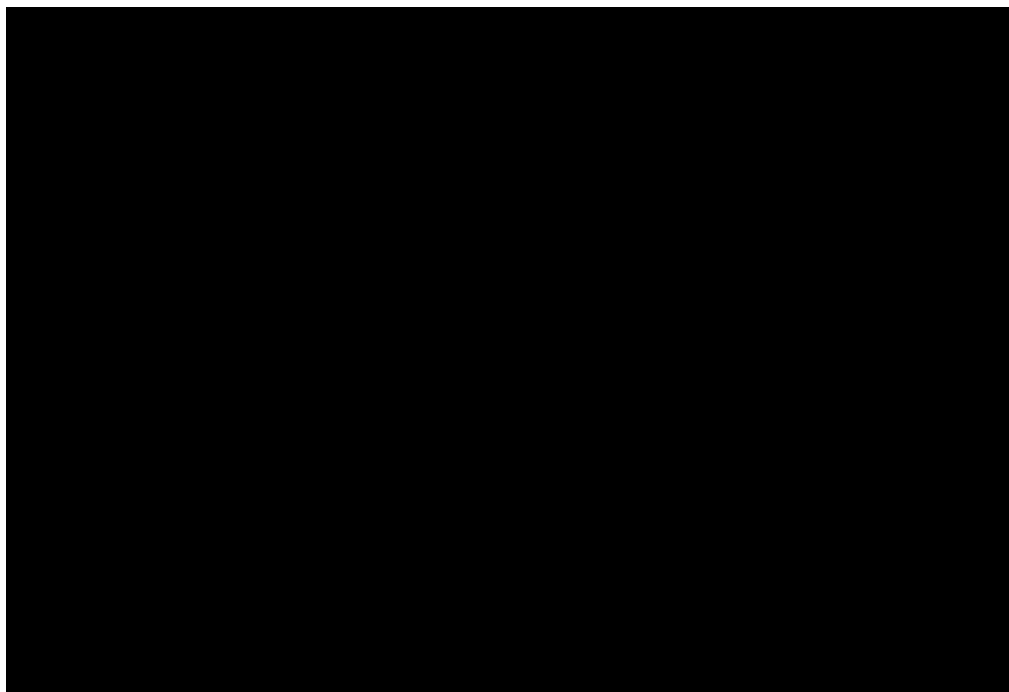

**Authority**

I am an Information Officer appointed by the Director-General under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act.

**Timeframes**

In accordance with section 40 of the Act TCCS is required to provide you with a decision on your application by 24 October 2022.

**Decision on access**

A search of TCCS records to has been completed, and no relevant records have been identified. I find these searches to be exhaustive and no relevant information is held.

**Charges**

Pursuant to *Freedom of Information (Fees) Determination 2018* fees are applicable where a release of information exceeds 50 pages. No fee is applicable to this application, as no relevant information has been identified.
