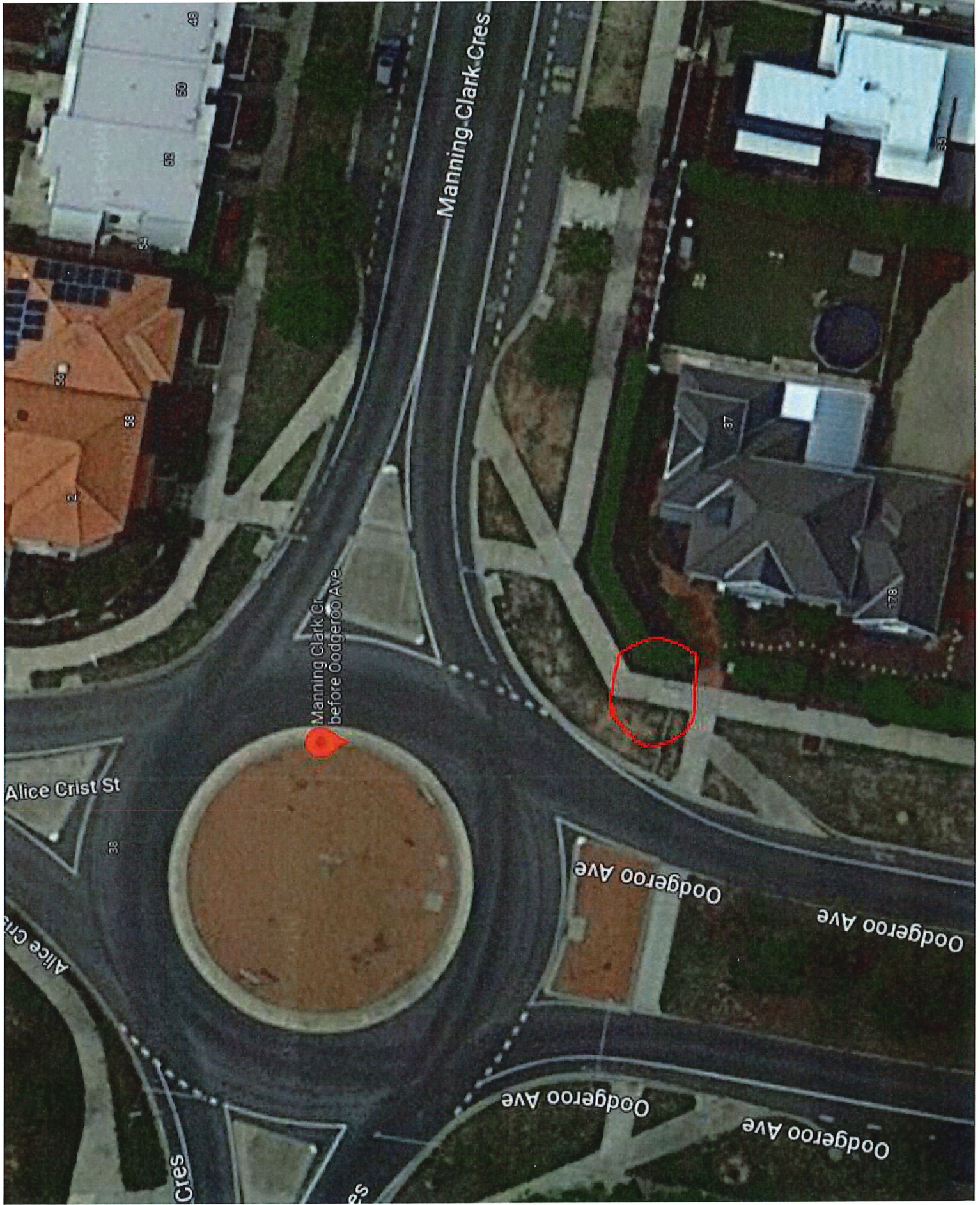
We act for [REDACTED] in relation to a claim for personal injury damages arising from a public liability accident in the Australian Capital Territory on 28 January 2023.
