Freedom of Information Request - Reference 23-118

I refer to your application for access to government information received by Transport Canberra and City Services (TCCS) on 10 October 2023 in which you sought access to the following government information:

"I am after the feedback that was submitted in the community consultation for the Evatt Shops upgrade. In particular I am seeking to know the number of people that commented in favour of a public toilet and the number of people that commented against a public toilet. If this information can be provided in less than 50 pages, that would be great."

I thank you for providing the following views on the public interest:

"The initial design did not address a public toilet so none of the questions were in relation to a public toilet specifically, leaving responders to add this request via additional comments. Additionally, the What We Heard report states "A common theme in the feedback was for a public toilet to be installed at the local shops noting the lack of facilities currently available. We also heard from a number of people who did not want to see a public toilet installed, concerned about the opportunity for antisocial behaviour and ongoing maintenance required." This information appears to be vague and potentially misleading so I am just after the number of those that requested a public toilet, versus the number of those that were against a public toilet. To make a decision that would be considered in the best interest of the local public, I believe the local public should be provided with better statistical information instead of "A common theme" and "A number of people".

Timeframes

A decision is due on your access application by 21 November 2023.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the FOI Act.

Decision on access

In accordance with the FOI Act, a search of TCCS records has been completed and four records have been identified as relevant to your application.

In reviewing the information within these records, and applying the public interest test under section 17 of the FOI Act, I have decided to provide you with:

- Partial access to 2 records: and
- Full access to 2 records.

Reasons for my decision are detailed further below in the statement of reasons.

Statement of Reasons

In making my decision on disclosing government information, I must identify all relevant factors in schedule 1 and 2 of the FOI Act and determine, on balance, where the public interest lies. In reaching my access decision, I have taken the following into account:

Schedule 1:

• No relevant factors identified.

Schedule 2:

Factors favouring disclosure in the public interest (Schedule 2.1)

- Section 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability;
- Section 2.1(a)(viii) reveal the reason for a government decision and any background or contextual information that informed the decision; and
- Schedule 2.1(a)(xiii) contribute to the administration of justice generally, including procedural fairness.

Factors favouring non-disclosure (Schedule 2.2)

• Section 2.2(a)(ii) - prejudice the protection of an individual's right to privacy or any other right under the *Human Rights Act 2016*.

In reviewing the relevant records, personal information relating to third parties has been identified. I find that factor 2.2(a)(ii) is relevant to this information and I must consider if the disclosure is likely to prejudice the protection of an individual's right to privacy under the *Human Rights Act 2004*. I have found that this information is not readily available to the public and has not otherwise been disclosed by TCCS. I find that the protection of an individual's right to privacy under the *Human Rights Act 2004* carries significant weight. In this instance, I have found the disclosure of personal information to be, on balance, contrary to the public interest.

I find that the factors favouring disclosure can be met with the deletion of information that is contrary to the public interest. A schedule of the relevant records is enclosed at <u>Attachment A</u> and a copy of the relevant records with deletions applied to information contrary to the public interest is enclosed at Attachment B and C.

Charges

In accordance with <u>Freedom of Information (Fees) Determination 2018</u>, a fee of \$0.35 per page of information disclosed, except for the first 50 pages, may be applied to an access application. No fee is applicable as the total number of pages is within this fee-free threshold.

Online publishing – disclosure log

Under section 28 of the Act, TCCS maintains an online record of access applications called a disclosure log. A copy of your application, my decision and records disclosed to you will be published on the <u>TCCS Disclosure Log</u> within 3 – 10 business days. Your personal information will be deleted from these copies prior to publication.

Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek an Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in TCCS' disclosure log, or a longer period allowed by the Ombudsman.

Hello Team,

Just a few thoughts around the Evatt shops proposed upgrade.

I won't comment on the play area, as my children are no longer in that age group, others might have more feedback.

First thing to note, most of the upgrade is focussed behind the shops. There is little to improve the façade of the shops – can the outside be painted and refreshed? All a bit haphazard at present and too much white everywhere!!

There appears to be a proposed tree (marked in light green with a circle), right in front of the IGA. Some nice planters with flowers would be lovely but imagine there would be concerns around access and vandalism. Trees for shade are important, but I think that is not the right position for one to be planted, mess would require cleaning up and may cause access issues. I have not noticed that the plan aims to improve disabled parking accessibility. Are we fixing something that's not broken? Or have there been complaints? The current disabled spots seem to be working fine from my observations.

The biggest omission from the proposal is a public toilet. These are sadly lacking in many of the older shopping precincts, and they are an essential service.

Approaching the shops from Clancy St the area near the sign is not attractive at all, can that be improved? I love the trees in the carpark, they provide much needed shade. Some shade sails in the parking area would be appreciated in summer.

The BCC is a not-for-profit, government-funded community organisation. The Belconnen Community Council (BCC) is an advocacy group that represents the interests of our members and the community on a range of matters affecting the people who live, work, and play in the Belconnen District.

As the voice of Belconnen for over three decades, with over 100,000 people in our catchment, we are intimately engaged with good and bad processes. We are uniquely positioned to offer observations on what works for all sides of the channels we engage with.

Local shops are more than just commercial entities; they are integral threads in the fabric of a community, contributing to its economic, social, and cultural vitality. By ensuring that these areas are safe, accessible, and aesthetically pleasing, we promote local business and create spaces where our community can come together, connect, and flourish. As such, we welcome the ACT Government's investment in upgrading local shopping centre precincts across Canberra.

The BCC highlights several positive aspects of the preliminary design:

- Tree Replacement: The move to replace unhealthy trees in the car park area is a commendable one. This not only aligns with aesthetic enhancement but also promotes ecological responsibility.
- **Landscaping**: The proposed landscaping will uplift the precinct's aesthetic appeal; this could be further enhanced with additional tree planting.
- Additional Seating: This would be incredibly beneficial, especially to the elderly and parents or guardians frequenting the nearby primary school.
- **Play Area:** The idea of having a play area is an excellent one, catering to both school-going and pre-school children. It would serve as a recreational space and a focal point of community interactions.
- **Pathway Upgrades**: Enhancing the pathway leading to and from the shops would improve safety and accessibility.
- **Carpark Improvements**: These improvements should alleviate some of the parking pressures during peak times and aid people with disabilities.

However, a longstanding concern among the community, especially our younger and older residents, has been the absence of toilet facilities. While we understand the constraints of budgeting, we believe that toilets would be an essential addition, particularly given the

introduction of a play area. Inclusion of such facilities would stand testament to the government's commitment to equality, inclusion, and accessibility.

The BCC looks forward to further engaging with the relevant stakeholders of this project to promote the best outcome for the community.
