# Authority

I am an Information Officer appointed by the Director-General under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act.

#### **Timeframes**

In accordance with section 40 of the Act, a decision is due on your access application by 30 June 2022.

# **Decision on access**

A search of records held by TCCS has been completed and the two briefs you are requesting access to have been identified.

I have refused access under section 35(1)(c) of the FOI Act to the information within these briefs. This is because it is contrary to the public interest to disclose. My access decision is detailed further in the following statement of reasons.

#### Statement of Reasons

In making my decision on disclosing government information, I must identify all relevant factors in schedule 1 of the FOI Act. Where information is not subject in full or part to schedule 2 of the FOI Act, I must determine, on balance, where the public interest lies.

In making my decision, I have also taken the following into account:

- The FOI Act; and
- The content of the documents that fall within the scope of your request.

Contrary to the public interest information under schedule 1 section 1.6 of the Act (Cabinet Information).

In reviewing the information within these records, I have found schedule 1.6 relevant, namely that the information is Cabinet information and is deemed to be contrary to the public interest.

I note the requirements of schedule 1 section 1.6(2) of the Act which states that the exemption for Cabinet Information does not apply to 'purely factual information' unless the disclosure of the information would involve the disclosure of a deliberation or decision of Cabinet and the fact of the deliberation or decision has not been officially published.

The term 'purely factual material' does not extend to factual material that is an integral part of the deliberative content and purpose of a document or is embedded in or intertwined with the deliberative content in such a manner that it is impractical to separate it from the other content.

Having reviewed the documents, I consider that some of the information within the documents identified is an integral part of future deliberations and decisions of Cabinet. I am satisfied that disclosure of such information contained in this document would be contrary to public interest pursuant to schedule 1 Section 1.6 of the Act.

#### Charges

Pursuant to Freedom of Information (Fees) Determination 2018 no fee is applicable as no information is to be disclosed.

## Disclosure log

Under section 28 of the Act, TCCS maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents

released to you will be published on the TCCS disclosure from 3 days after the date of this decision.

#### Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in TCCS' disclosure log or a longer period allowed by the Ombudsman.
