Under section 34(3) of the *Freedom of Information Act 2016* (the Act), I am writing to seek clarification regarding the scope of your request.

As discussed, you confirmed that you are seeking the following information:

- Data relating to the *entire ACT Public Service*, rather than a specific directorate.
- The *actual number of employees* who have been stood down with pay.
- You are *not* seeking the reasons for the stand-down, but only the number of employees within the following duration categories:
 - Less than 6 months
 - 6 to 12 months
 - More than 12 months
