I refer to your application made under section 30 of the *Freedom of Information Act 2016* (the FOI Act) that was received by Transport Canberra and City Services (TCCS) on 11 August. It is my understanding that you are seeking access to the following information:

"I wish to have a copy of the residential impact assessment associated with the expansion of Parkes Way lanes on the city side of the ANU tunnel to the Nishi building, and the same for the speed increases around the tunnel - as such documents relate to noise and residential nuisance. I also seek any subsequent noise or residential nuisance related assessments associated with that same area of road undertaken since the lanes expanded and the speed was raised... I only want material directly relevant to Parkes Way from the Nishi building to the ANU tunnel. I am not seeking reports for the whole road."

### **Authority**

I am an Information Officer appointed by the Director-General under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act.

#### **Timeframes**

In accordance with section 40 of the Act, TCCS was required to provide a decision on your access application by 8 September 2022. I thank you for agreeing to an extension on your application until 7 October 2022.

## **Decision on access**

A search of information held by Transport Canberra and City Services (TCCS) has been concluded and no documents relevant to your request have been identified. I have decided that the search was sufficient and no information is held by TCCS.

## Charges

Pursuant to *Freedom of Information (Fees) Determination 2018* processing charges are applicable where more than 50 pages are disclosed. No fee is applicable to your application, as no relevant information has been identified.
