I refer to your application for access to government information received by Transport Canberra and City Services (TCCS) on 12 February 2022 seeking access to the following government information under the *Freedom of Information Act 2016*:

Timeframes

A decision is due on your access application by 15 March 2022.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the FOI Act.

Decision on access

In accordance with the FOI Act, a search of TCCS records has been completed. This search identified 20 records as relevant to your application.

Upon reviewing the information within the remaining six records, and applying the public interest test under section 17 of the FOI Act, I have decided to provide you with:

- full access to nine records; and
- partial access to 11 records.

The reasons for my decision are provided below under the heading 'statement of reasons'.

The documents are listed in the schedule at <u>Attachment A</u>, and a copy of the records with deletions applied to the information I have found to be contrary to the public interest is at <u>Attachment B</u>.

Statement of Reasons

In making my decision on disclosing government information, I must identify all relevant factors in schedule 2 of the FOI Act and determine, on balance, where the public interest lies. In reaching my access decision, I have taken the following into account:

Factors favouring disclosure in the public interest (Schedule 2, Section 2.1)

- Section 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability; and
- Section 2.1(a)(viii) reveal the reason for a government decision and any background or contextual information that informed the decision.

Factors favouring non-disclosure (Schedule 2, Section 2.2)

- Section 2.2(a)(ii) prejudice the protection of an individual's right to privacy or any other right under the *Human Rights Act 2016*; and
- Section 2.2(a)(xii) prejudice an agency's ability to obtain confidential information.

In reviewing the relevant records, personal information relating to third parties has been identified. I find that factor 2.2(a)(ii) is relevant to this information and I must consider if the disclosure is likely to prejudice the protection of an individual's right to privacy under the *Human Rights Act 2004*.

I acknowledge that you are familiar with the name and contact details of your neighbours. However, I have found that this information is not readily available to the public and has not otherwise been disclosed by TCCS. I find that the protection of an individual's right to privacy under the *Human Rights Act 2004* carries significant weight. In this instance, I have found the disclosure of personal information to be, on balance, contrary to the public interest.

However, I find that the disclosure of your partner's information to you is not contrary to the public interest as the records show that TCCS has previously corresponded with you both, and this information is already known to you.

I have found that the factors favouring disclosure can be satisfied with the deletion of information which is contrary to the public interest. A copy of the relevant information is enclosed at <u>Attachment B</u>.

Charges

I have decided to waive the fees associated with this request because the number of pages being released only marginally exceed the fee-free threshold.

Online publishing – disclosure log

Under section 28 of the Act, TCCS maintains an online record of access applications called a disclosure log. Your application and my notice of decision will be published on the <u>TCCS Disclosure Log</u> within 3 - 10 business days. Your, and your partner's, personal information and the residential house numbers relating to this application will be removed from the documents prior to publication.

Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek an Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in TCCS' disclosure log or a longer period allowed by the Ombudsman.





Hi Brent,

I have spoken to **and advised** him that the tree protection unit do not get involved in neighbourhood disputes and that he should contact the conflict resolution service or the ACT Civil and Administrative Tribunal (ACAT) to determine an outcome. However, he is insistent on submitting an application without consent to enter the property of where the tree is located, as he is of the opinion that the tree is a schedule 2 species and threatening to cause damage to his property and would like an inspector to assess the tree from his side of the fence. He is going to file a complaint through ACAT and would like a conservator's decision notice to allow removal of the tree if it satisfies criteria, so that ACAT can make a decision.

I did advise that we may not be able to determine a decision based on a partial tree inspection and he understands this, although he would like to proceed with the application.

I have spoken to Geoff and advised him that I would like you to arrange a time to attend the site inspection with him.

Let me know if you would like to discuss further.

Regarding Eucalyptus saligna at

- I received the application on the 5 January 2022.
- Inspected the tree on 6 January 2022 at 9 am.
- Spoke to owner on site.
- The tree appeared to be structurally sound with one broken branch in canopy.
- The branch was still attached to the trunk and was supported by the lower canopy.
- At the time of inspection the branch was secure within the tree.
- I informed the resident that the tree would probably be approved due to its position and potential size.
- I noticed a small fungal fruiting body in the trunk of the tree.
- I informed the applicant that he would receive a letter in the mail, as the tree did not meet criteria for Urgent Circumstances.
- At approximately 2.00 pm I received a telephone call from the applicants neighbours who were quite concerned about the hanging limb.
- I informed of the process mentioned above and that it did not meet approval for urgent circumstances.
- They asked if the limb could be secured by rope, which I agreed with.
- I informed that, at the time of inspection the branch was secure within the tree, but could not guarantee that it would probably sustain another extreme weather event, as seen on the 3 January, and suggested contacting an arborist to remove the branch.
- They informed me that they had tried, but they were all busy.
- They asked me if the government crews could do it? I informed them that government crews were not allowed to do work on private property.
- Then they asked me if I could influence a local arborist into doing the job ASAP. I informed that I was a government official and that it would be inappropriate for me to try and coerce a private company into doing their job.
- They informed them they would be writing to the minister.
- End of conversation.

Hi Jemma,

Thanks for your email - we have been in touch with TCCS who put us in contact with Mr Jeffrey Lewis-Hughes at the Tree Protection Unit.

Jeffrey said he inspected the tree and limb this morning at 9am (with our neighbour), and has deemed the tree as currently being safe, but will recommend that it be removed.

However, after some discussion with Jeffrey, he agreed that the currently safe status of the tree could change during the next storm in that it could become dislodged.

Therefore we asked him if the Government could priorities an arborist to make it safe in the near term by securing the dangerous limb with some ropes, before it is dislodged in the next storm. Jeffrey's response response was that the Government doesn't engage directly with arborists and that our neighbour needs to arrange for an arborist.

Whilst it is great that the Tree Protection Unit will recommend removal of the tree in the long term, we continue to live with a tree safety hazard over-hanging our house in the near term.


This is unacceptable from our perspective as we cannot use our bedrooms and need to closely monitor our children's movements to ensure they are not in the wrong place at the wrong time.

Since my neighbour has been unsuccessful at identifying a suitably qualified arborist, I have been able to organise for a qualified arborist from ACT Tree Felling to inspect the tree on 17 Jan, which is the earliest they could fit us in. It is unclear how long we will have to wait for ACT Tree Felling to be able to remove the tree. Hence, it is unclear how long we will be unable to use our bedrooms.

We continue to have an anxious wait for an arborist as there are more severe thunderstorms forecast over the next week. It is a shame that Jeffrey didn't view the tree from our property to better appreciate the risk it presents to our house and our safety. He would not have seen the SES tape that put in place to cordon off the back of our property.

To say we are disappointed is an understatement. We will continue to work with our neighbour to chase down an arborist but I don't think we will be able to make the tree safe in the near term. Regards,





Please find below email and attachment with more background information - the attachment contains the request/application to Minister Steel's office on 5 Jan 22. In response to this request, the Tree Protection Unit sent an inspector to inspect the tree on 6 Jan 22 at 9am - which I was not made aware of, which was disappointing. Unfortunately the inspector did not inspect the tree from our property to understand the amount of overhang (which continues to grow) and the risk this presents to the safety of our property and family.

On 14 Jan 22, I called Geoffrey and he confirmed that the application was still being processed by the Conservator and that a Notice of Approval (in the form of a letter) should be provided by the end of January. Hence, my follow-up phone calls today to check on the progress of the letter.

Since the severe storm on 3 Jan 22, two arborists have confirmed that the subject tree is a Eucalyptus viminalis. Our research indicates that this species of Eucalyptus will continue to grow and could reach 90 m in height. Parts of the tree are already rotting due to animal habitation, which led to the limb that fractured on 3 Jan and presented a risk to our safety. "This species of tree should not be in a suburban backyard", as quoted by one of the SES staff that answered our call on 3 Jan 22.

Executive Summary

This report provides a summary of key points and information regarding the Eucalyptus viminalis tree ('Tree'), which originates at

qualified arborist has confirmed the species of the Tree to be a Eucalyptus viminalis and has stated that he has never seen this fast-growing species of Tree positioned so close to houses on a private property. A severe storm event in the Australian Capital Territory (ACT) on 3 January 2022 ('Storm') has revealed structural integrity problems with the Tree, which is considered dangerous and inappropriate for its location. Major pruning will not eliminate the unacceptable risks associated with the Tree. This report is designed to support an Application to Undertake a Tree Damaging Activity under the basis of ACT legislation.

ACT Government design standards clearly indicate the Tree species is unsuitable for residential properties in suburbia; particularly on a shared fence line in the middle of a block as is the case with the Tree. A quick survey of the **suburbia** suburb shows that the Tree is one of the largest in the local area, including The Pinnacles parkland region. It is also larger than Eucalyptus viminalis trees at the Australian Botanical Gardens. A summary of key points from ACT Government design standards is provided as follows (emphasis added):

- Suitable for use in open parklands on flatter deeper soils and along watercourses, not suited for road verges, or in screening or shelter belts
- Fast growth rate in good conditions
- High flammability
- Susceptible to a wide range of indigenous pest species
- Drops litter all year, including large bark ribbons, and can drop large branches
- This tree can quickly develop faults and is not ideal where formal longevity is needed

Listed as problematic tree species under the Tree Protection Act 2005.7

Key points regarding the Tree at

is provided as follows:

- Species and potential growth. The Tree is a fast-growing species⁸ that can reach 50 m to 90 m in height.⁹ A qualified arborist has estimated the Tree is more than 40 m tall hence the Tree may grow a further 10 to 50 m. As the Tree canopy, trunk and roots continue to grow, this will increase the risk to life and property.
- Location. The Tree's trunk is located on land at approximately 1.5m from the boundary fence-line and adjacent to residential houses, but closer to the house at A map with a 'drop pin' indicating the Tree's location is provided at figure 1.
- Site plan constraints. The 2012 site plan for the property at confirms there used to be 2.2 m of clearance between the house and the Tree canopy. The floor plan had to be designed to meet Energy Efficiency Rating (EER) requirements. The position of the house (rebuild) was then constrained to protect trees and a lamp post at the front of the property; and to protect trees at the rear of the property. The build also needed to maintain spacing from a public pathway on the northern side. See figure 2.
- Tree encroachment overhang. The Tree has grown significantly since 2012, and there is
 now an encroaching overhang that extends over the house at
 including three bedrooms. See figures 3 to 5 inclusive.
- Uneven tree maintenance. Photographs suggest only one side of the tree is being maintained through limb and branch removal the south facing side, which faces
 The Tree appears to have uneven limb growth due to the suggested bias towards maintaining the south facing side of the Tree. See figure 3.
- Risk of structural failure. The Storm has revealed problems with the Tree at 'V' sections in the tree where large limbs attach to Tree trunks on the other side of the fence – at
 The large limb that fractured during the Storm showed signs of deterioration at its base 'V' section – a qualified arborist has confirmed the deterioration was most likely due to animal habitation and trapped water.




Figure 6: Tree Damage and Animal Habitation (3 Jan 22)

- There were signs of animal habitation after the Storm with a possum returning to the 'V' section. Animal habitation continues since removal of the limb with cockatoos that regularly sit on the damaged limb. Signs of deterioration extend upwards from the 'V' section, suggesting they would have been visible before the limb fractured. <u>See figures 6 to 8 inclusive</u>.
- Other 'V' sections on the Tree are showing signs of deterioration (blackness), likely due to trapped litter (bark) and trapped water. Deterioration in 'V' sections pose a risk of structural failure, evidenced by the large limb that fractured during the Storm.¹⁰ See <u>figure 9</u>.
- Risk of falling. Following the Storm, the SES received 834 requests for assistance, largely
 in relation to fallen trees causing structural damage and leaking roofs.¹¹ Dozens of
 eucalyptus trees in Weetangera and surrounding suburbs were blown over during the
 Storm photos can be provided upon request. Many of these appeared to be
 otherwise healthy trees but their root systems were ineffective in the wet soil and unable
 to support their weight during the Storm. Future weather events could have a similar
 impact on the Tree, causing it to fall over, which could have catastrophic
 consequences, causing serious injury or death. It could also result in expensive damage
 to our property and that of your clients. The risk of harm is foreseeable, and not
 insignificant. Major pruning will not eliminate this unacceptable risk.
- We are extremely concerned about the risk of limb and branch failure and the possibility that such failure may cause substantial damage to our property; and/or injure our family and visitors.




Nuisance Factors

Ongoing growth of the Tree has led to substantial and unreasonable interference with our use of the land as a result of the Tree. We are unable to enjoy the full use of our property. As the Tree canopy, trunk and roots continue to grow, this will increase the nuisance factors summarised as follows:

- Unreasonable amounts of litter. The tree constantly drops litter in the form of branches, twigs, long strips of ribbon bark, small cup shaped fruit and leaves across the entirety of our property – especially during the summer season. We are regularly required to clear an excessive amount of litter from the Tree to keep our property clean and to minimise the damage caused by stains to concrete and the pool area. The amount of effort we have to make to keep our property clean from Tree litter is unreasonable. The volume of litter is increasing each year as the tree continues to grow. <u>See figures 10 to 18 inclusive</u>.
- Encroaching roots. The Tree's root system is encroaching onto our land, with obvious signs of soil damage and dead lawn. On 7 July 2019, whilst playing soccer with my children, the uneven surface caused by encroaching tree roots caused me to tear my right calf muscle, which took some weeks to heal. This area of the garden contains an uneven surface and trip hazards due to encroaching roots. See figure 19.
- The Tree's root system also presents a risk of causing damage to underground infrastructure including power cables (parallel to the fence line), reticulation, plumbing and foundations of the house. <u>See figures 19 and 20</u>.
- Unusable land. Of greater concern is the risk of the tree dropping large limbs and branches on play areas in the garden or the thoroughfare that we use to get to the rear of our property. We need to avoid using the deteriorated grassed area adjacent to the Tree due to the risk of branches falling from the Tree; and the trip hazard from encroaching Tree roots. The area is 11m x 8m square (88m²) approximately 25% of the total grassed section in the backyard that is unusable.








- The Tree is a hazard, giving rise to a foreseeable risk of harm to residents and risk of damage to property. The foreseeable risks are increasing due to ongoing tree growth; wet soil impacting root system effectiveness; and severe storm events.
- Eucalyptus viminalis is fast growing and can reach heights up to 90m. The Tree is dangerous and too large for its location. The tree is a nuisance, preventing enjoyment of property.
- The Tree has grown significantly since 2012 when there was no overhang on the house
- The tree is more than 40 m tall and has not been maintained evenly, either side of the fence line – it is leaning towards

overhanging all bedrooms

- Heavy limbs and branches grow from 'V' sections, that have high stress concentration and become weakened by rot and damage from animal habitation, such as occurred in Storm event on 3 Jan 22
- The Tree is prone to animal habitation and rot forming from long ribbon strips of bark getting trapped in the 'V' sections
- The Tree is prone to dropping limbs; and litter in the form of bark, leaves and sticks
- Encroaching roots cause uneven ground, trip hazards, kills lawn, ruins soil and causes concern for house foundations.




Figure 7: Tree Damage After Limb Removal (5 Feb 22)




Figure 8: Tree Damage & Animal Habitation After Limb Removal (31 Jan 22)





Figure 9: 'V' Section with Signs of Deterioration and Trapped Water (31 Jan 22)




Figure 13: Tree Litter - Large Bark Strips (31 Jan 22)




Figure 15: Ruined Sandpit from Tree Litter (31 Jan 22)




Figure 18: Tree Litter on Roof (4 Feb 21)




Figure 19: Encroaching Roots – Dead Lawn and Trip Hazards (12 Jan 22)

The Conservator's Decision (attached) is internally reviewable. You may apply for reconsideration of the decision under section 107 of the Act. The application must be in writing and must set out the grounds upon which reconsideration of the decision is sought. The application fee is \$121.70 under the *Tree Protection (Fees) Determination 2021 (No1) 1.1.* s 106 of the Act from 1 July 2021.

An electronic (Application for Reconsideration) "Smartform" is available to download via the <u>Access</u> <u>Canberra website</u> link: <u>https://form.act.gov.au/smartforms/servlet/SmartForm.html?formCode=1096</u> The application must be made within **14 days** of the date of this notice by **Monday 7 March 2022.** An application for internal review will suspend any regular activity on tree/s subject to the reconsideration appeal. The review process may take 60 days and may confirm, vary or set aside the first decision.

If you do not agree with the reconsidered decision, you may apply to the ACT Civil and Administrative Tribunal for review of the decision. You may also seek review of the decision under the Administrative Decisions (Judicial Review) Act 1989. You may also contact the ACT Ombudsman if you have concerns about the decision.

Please Note: If an aerial inspection is carried out by a qualified arborist and further concerns or damage noticed, please provide the arborist's report in a new application to the Conservator.
