Freedom of Information Request - Reference 22-092

I refer to your application for access to government information received by Transport Canberra and City Services (TCCS) on 17 June 2022 seeking access to the following government information under the *Freedom of Information Act 2016*:

“All documents relating to the investigation of the firewood delivery carried out by a TCCS vehicle at McConnel Cres, Kambah”.

Timeframes

A decision is due on your application by 15 July 2022.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the FOI Act.

Decision on access

In accordance with the FOI Act, TCCS has identified all relevant information to your application. In reviewing the information, it was identified that the information is subject to an ongoing investigation. I have found that this information is subject to schedule 1.14 of the *Freedom of Information Act 2016*, as the disclosure of information could reasonably be expected to prejudice the investigation of a convention or possible contravention of the law in a particular case. As such, the disclosure of the information is deemed to be contrary to the public interest at this time.

Charges

Pursuant to *Freedom of Information (Fees) Determination 2018* processing charges may be applicable where the total number of pages disclosed exceeds 50. As no information is to be disclosed, no fee is applicable.

Online publishing – disclosure log

Under section 28 of the Act, TCCS maintains an online record of access applications called a disclosure log. Your original access application and my decision will be published in the TCCS disclosure log between 3 – 10 business days from the date of this decision.

Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek an Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in TCCS' disclosure log or a longer period allowed by the Ombudsman.
