What information are you requesting access to under the Act? *

I am seeking details about the plans submitted by a building contractor (Paynters) for a site office on Marcus Clarke St for works on the roof (repairing hail damaged roof). The camp - an office for the foreman, a tea room and a toilet shed, three containers in total in a large, fenced area - requires electricity, water and a ewage outlet to function.

Was Owners Corporation approval gained prior to submission of the plans?

Water i trucked in, and another truck uck the wa te out of the toilet block. And the whole ite require electricity. This electricity is drawn from the building being repaired, via holes drilled through external walls, and power cables run through conduit suspended above the footpath from the building to the site. It is not a small camp. See short video uploaded for an idea of its scale.

The Strata Manager insists she only found out about the site when approval was granted by TCCS. The foreman does not know the detail as it was requested by the company prior to him starting on the site. So, absent any clear information from the key parties I am seeking confirmation from TCCS that Owners Corporation agreement to upply power wa gained prior to the ubmi ion of the plan for thi ite.

Note - this is not a 'brown fields' construction site where a camp like this is justified. It is an office for one, a place for meetings of up to 8, a tea room and a toilet. Less than the footprint of a one bedroom apartment of which we have many vacant inside the building, so the decision to not use these options and camp outside requires an explanation. And no credible explanation has been available to date. Hence our request.

Also, we know there is a 20 day turn around and there are Public Holidays coming, however it would be really appreciated if this could be resolved by the morning of 9 May as we have a Committee Meeting that evening which will be informed by this information. Or not, depends on what is available.

Provide a statement about how the release of information is in the public interest (optional)

This is an interesting edge case. In theory the ACT govt is only interested in the nature strip (approving its use in this case) and rightly assumes the Owners Corporation is representing the interests of the residents in the building. The Owners Corporation for its part, in theory, has no interest in what a builder is applying for when using Territory land adjacent to the building. OK. However, what about a case like this where the site, if approved by TCCS can only work if it draws power from the building? Does the ACT Govt require confirmation that power supply has been confirmed prior to submission of their plans?

If this is currently not the case, then perhaps the approval process might benefit from having Owners Corporation signature on applications like these just to make sure that builders are consulting Owners Corporations, and Strata Managers on residents' behalf are also signing that they have agreed to supply power.

Because it does not make sense that the Owners Corporation can be 'surprised' by a site office going up on the lawn and drilling holes through walls to access electricity.

I have attached a short clip of the water truck servicing the camp to give an idea of the scale of this thing, and hence how incredible it is that Owners Corporation agreement was not gained prior to it being installed. If not, formal agreement should be required.

All we need from you, please, is confirmation the agreement to draw power was provided by the Strata Manager to the building contractor prior to submission of the builder's plans for approval to use TCCS land. We do not need names, prices or any other contractual info, just this Owners Corp confirmation.

I refer to your application for access to government information received by Transport Canberra and City Services (TCCS) on 13 April 2022 seeking access to the following government information under the *Freedom of Information Act 2016* (FOI Act):

" I am seeking details about the plans submitted by a building contractor (Paynters) for a site office on Marcus Clarke St for works on the roof (repairing hail damaged roof)... confirmation from TCCS that Owners Corporation agreement to power was gained prior to the submission of the plans for this site."

I note that in your application you raised a few questions which fall outside of the scope of the FOI Act. Where possible, I have provided answers to these questions in the below section 'decision on access'.

Timeframes

In making your application, you requested a decision to be provided to you by 9 May 2022. Unfortunately, we were unable to meet this request.

In accordance with section 40 of the FOI Act, a decision is due on your access application on 16 May 2022.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the FOI Act.

Decision on access

In accordance with the FOI Act, a search of TCCS records has been completed. This search identified 16 records as relevant to your application.

In reviewing the information within these records, and applying the public interest test under section 17 of the FOI Act, I have decided to provide you with:

- Full access to 2 records; and
- Partial access to 14 records.

The documents are listed in the schedule at <u>Attachment A</u>, and a copy of the records with deletions applied to the information I have found to be contrary to the public interest is at <u>Attachment B</u>.

In relation to your questions, I provide the below:

- TCCS cannot confirm Owners Corporation approval of the site compound arrangement. Record 16 shows that the proposal was circulated on 17 November 2021. However, the ACT Government was not party to these conversations. TCCS was provided a copy of this email by Paynters.
- TCCS cannot confirm Owners Corporation approval for the use of the building's power supply. In this case, the land use application relates to the temporary use of public land for a site compound only, TCCS does not generally request details associated with power provided from a private source, unless it can potentially impact pedestrian/ vehicle movements. If a power source is requested from a Territory asset or trenching required, potentially damaging Territory assets, further information will be requested.

Statement of Reasons

In reaching my access decision, I have taken the following into account:

- The FOI Act
- The Human Rights Act 2016
- The scope of your application

In making my decision on disclosing government information, I must identify all relevant factors in schedule 2 of the FOI Act and determine, on balance, where the public interest lies. I have taken the following sections of schedule 2 into account:

Factors favouring disclosure in the public interest (Schedule 2, Section 2.1)

- Section 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability; and
- Section 2.1(a)(viii) reveal the reason for a government decision and any background or contextual information that informed the decision.

Factors favouring non-disclosure (Schedule 2, Section 2.2)

• Section 2.2(a)(ii) - prejudice the protection of an individual's right to privacy or any other right under the *Human Rights Act 2016*; and

In reviewing the relevant records, personal information relating to third parties has been identified. I have considered that this information is not readily available to the public and the disclosure of this information is likely to prejudice the protection of an individual's right to privacy under the *Human Rights Act 2004 and* carries significant weight. In this instance, I have found the disclosure of personal information to be, on balance, contrary to the public interest.

I have found that the factors favouring disclosure can be satisfied with the deletion of information which is contrary to the public interest. A copy of the relevant information is enclosed at <u>Attachment B</u>.

Charges

No fee is applicable to this application, as the total number of pages falls within the fee free threshold.

Disclosure log

Under section 28 of the FOI Act, TCCS maintains an online record of access applications called a disclosure log. A copy of your application, this decision notice and the information disclosed to you will be published on the <u>TCCS disclosure log</u> within 3 - 10 business days. Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. National Capital Authority Works Approval will be required for any works undertaken on National or Designated land.

The contractor shall liaise with the Transport Canberra Light Rail project surveillance officer Graham Hampton (graham.hampton@act.gov.au or at least 2 business days prior to implementing the authorised traffic guidance schemes.

The contractor shall contact TCCS Traffic Signals, Roads ACT) 6207 5222 or tccs.trafficsignalsection@act.gov.au at least 24 hours prior to implementing any lane / road closures on the approaches to signalised intersections which will affect traffic signal operations.

The contractor shall liaise with Transport Canberra Field Operations at least 24 hours prior to installing any lane / road closures or traffic controller operations on any Transport Canberra service delivery route. Access to bus stops shall be always maintained.

Marcus Clarke Street Daily Lane closure and or traffic controller operations shall not be installed before 9:00 am and shall be removed by no later than 4:30 pm Monday to Friday.

The contractor shall ensure advance warning signage advising road users of the proposed road closures shall be required to be installed in a prominent location at least 7 days prior to the commencement of the road closure.

TCCSD will require a dilapidation report to be undertaken on the condition of the assets located within the road / road related area under the area of works as shown on the authorised TTM drawing. Any damage to the assets located above or below

the ground will be repaired at the contractor's expense in accordance with TCCS Municipal Infrastructure Technical Specifications (MITS).

A Use of Public Land Application for Construction Activities will be required from TCCSD, City Services, Licensing and Compliance unit prior to any works commencing.

This work approval is granted for the following work activities only:

- Installation, modification, and removal of traffic control devices in accord with an authorised temporary traffic management plan.
- Excavation and construction on public unleased land

Note: All other land use requirements, such as material storage, site compounds and parking bay use, that require the use of public unleased land are likely to attract additional land use permits and associated fees. The contractor shall notify ACT Parking Operations <u>parking.operations@act.gov.au</u> to advise of the location, dates, and times when closures of regulatory parking control areas have been installed / removed.

Signs and devices shall be installed by a competent person who has the necessary training, skills and experience as defined in Austroads Guide to Temporary Traffic Management Part 8.

Site inspections and record keeping shall be undertaken and documented in accordance with the requirements of the Austroads Guide to Temporary Traffic Management Planning.

A record of dates and times temporary speed limits are in operation shall be kept, including any changes made, the name of personnel installing, changing, or removing signs (see Section 2.5.3 Austroads Guide to Temporary Traffic Management).

Any permanent speed signs that contradict the temporary speed limit in the required zone shall be covered or removed. The contractor shall ensure all permanent speed signs have been reinstated as per the authorised TCD drawing at the completion of each shift.

It is a mandatory requirement that any person who undertakes on-site traffic control tasks has successfully completed a State or Territory Road transport authority accredited traffic controller course provided by an accredited training provider.

Traffic controllers shall always keep their traffic controller's ticket with them on their person indicating their accreditation details. Traffic controllers are not authorised to undertake any on-site traffic controlling tasks unless they hold a valid accreditation as a traffic controller at the time. The contractor shall only install or display (or to interfere with, change or remove) a prescribed traffic control device during the authorised working times. Prescribed traffic control devices shall be fully covered or removed at all other times.

The contractor shall ensure that all temporary signs and devices are removed at the completion of these works.

Where pedestrians including people with disabilities or visual impairment have to move through, past or around a work site or to cross the road within a work site they shall be provided with and directed to suitably constructed and protected temporary footpaths and crossing points or formal pedestrian crossings or refuges if warranted.

The contractor shall provide advice to Pedal Power ACT regarding any works on or adjacent to any shared use path / on road cycle facility for the information and awareness of their members.

The principal contractor shall ensure that all directly affected businesses / residents and Government Agencies have been advised in writing at least 5 business days prior to these works commencing This letter shall include the following information.

- Scope of works to be undertaken.
- Proposed road closure dates and times.
- Access / egress arrangements for residents / commercial tenants during the road closure.
- Principal contractors' details including contact numbers to answer any enquiries in relation to these works.

Access to commercial and residential properties including any driveways shall be always maintained unless agreed to otherwise with the property owners prior to works commencing.



REQUIREMENTS FOR THE PROTECTION OF PUBLIC LANDSCAPE ASSETS ADJACENT TO DEVELOPMENT WORKS ON UNLEASED TERRITORY LAND - PUBLIC OPEN SPACE.

1 GENERAL

Fencing to be erected before the commencement of any site work and removed at completion of all construction and commencement of verge restoration. The fence is to remain continuous throughout the project. Fencing must not be removed for service installation across the verge unless in accordance with this plan. 2.3 EXISTING TREES

All street trees are to be retained and kept undamaged unless indicated on this plan and specifically approved in writing by TCCS Ensure construction equipment can pass beneath lowest limb, through driveway access. Ensure lifting equipment and load can clear height and width of tree crown without damage to crown. A suitably qualified arborist / landscape architect approved by TCCS Urban Treescapes must be present for all excavation works beneath tree canopies, restoration or any works that occur beneath tree canopies. Arborist is to provide regular inspections and reporting that all tree protection measures are being complied with and that the LMPP fencing is installed and maintained as approved.

Excavation within drip line of existing trees approved by Municipal Services' Asset Acceptance Section is to be undertaken by hand only. No machinery is to be used.

A qualified and experienced horticulturist or tree surgeon must carry out all root cuts and ensure the cuts are suitably protected to minimise any risk of long term damage to street verge trees. The majority of tree roots grow in the top 300mm of soil. These are the feeder roots, often very fine roots that provide the tree with water, oxygen and nutrients. These roots typically grow between the tree trunk to well beyond its 'drip-line' (the canopy edge). Excavation within the drip zone of a tree does considerable damage to its root system. It can affect tree stability and tree health to such an extent that it will lead to die back and decline of the tree. Excavation that occurs within the drip zone of a tree must be approved and is to

be restricted to one side of the tree only Where excavation is approved the following measures are to be adopted for tree

protection Do not sever large roots (>30 mm diameter) closer than halfway from the drip-line to

the trunk.

All roots must be cut cleanly with equipment specifically designed to cut roots or other pruning equipment.

Roots exposed during excavation must be protected from desiccation. Keep lightly watered or cover with hessian, which must be kept moist Water trees that have had disturbance in their root zone. The amount and frequency of water needs to be adapted to the trees' requirement, based on seasonal conditions




