Freedom of Information Request - Reference 22-061

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act) received by Transport Canberra and City Services (TCCS) on 20 April 2022 seeking:

to obtain a GIPA on the footpath outside 35 Empire Circuit Forrest ACT 2604 – the following information on the footpath:

- a) *Is the state of the footpath known to be in a “state of disrepair” by the Government?*
- b) *Have there been any incidents on that piece of footpath?*
- c) *Are there any proposed works to be completed on the footpath?*

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the FOI Act.

Timeframes

A decision on your application is due on 19 May 2022.

Decision on access

A search of records held by TCCS has been completed and no information relevant to your request was identified. I am satisfied that all appropriate searches were completed. Pursuant to section 35(1)(b) of the Act, I have determined that the information that you have requested is not held by TCCS.
