

Freedom of Information Request - Reference 22-135

I refer to your application for access to government information received by Transport Canberra and City Services (TCCS) on 4 October 2022 under the *Freedom of Information Act 2016* (FOI Act). It is my understanding that you are seeking access to the following government information:

"the subject line of all final ministerial briefs from 11th of June 2022 to 10th of July 2022 generated for or directed to any ACT Government Minister. This request includes, wherever possible, the date of the brief, the internal reference, position of authority it was written by, and which Minister it was addressed to. This request includes briefs prepared for Question Time, but not for Estimates or Annual Reports".

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the FOI Act.

Timeframes

A decision a decision is due on your access application by 1 November 2022.

Decision on access

In accordance with the FOI Act, a search was conducted of records held by TCCS. A list of all relevant information has been compiled into a format consistent with your request.

In relation to Question Time Briefs, I can advise that none were prepared for this period.

In reviewing the information within these records, I have found, on balance, it is in the public interest to provide you with partial access. This is because I have found some of the information to be contrary to the public in line with section 35(c) of the FOI Act. My decision is detailed further in the below statement of reasons.

Statement of Reasons

In making my decision on disclosing government information, I must identify all relevant factors in schedule 1 and 2 of the FOI Act and determine, on balance, where the public interest lies. In reaching my access decision, I have taken the following into account:

Schedule 1:

• Schedule 1.6(a) - Cabinet information

Factors favouring disclosure in the public interest (Schedule 2, Section 2.1)

- Schedule 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability;
- Schedule 2.1(a)(ii) contribute to positive and informed debate on important issues or matters of public interest; and
- Schedule 2.1(a)(iii) inform the community of the government's operations, including the policies, guidelines and codes of conduct followed by the government in its dealings with members of the community.

Factors favouring non-disclosure (Schedule 2, Section 2.2)

• No relevant factors were identified.

In reviewing information in record 16, I have identified information that a Minister proposes to submit to Cabinet for its consideration. The information is not currently available to the public, and if disclosed is likely to prejudice a deliberative process which is in progress. Consistent with the FOI Act, information found relevant to schedule 1 of the FOI Act is deemed contrary to the public interest.

I find that the factors in favour of disclosure can still be met, with deletions applied to information that I find to be contrary to the public interest. I have enclosed at <u>Attachment A</u> a copy of the record with deletions applied to information that is contrary to the public interest.

Charges

No fees are applicable, as the total number of pages are within the fee-free threshold.

Online publishing – disclosure log

Under section 28 of the Act, TCCS maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents will be published in the TCCS disclosure between 3 – 10 business days from the date of this decision.

Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek an Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in TCCS' disclosure log or a longer period allowed by the Ombudsman.
