Freedom of Information Request - Reference 24-012

I refer to your application for access to government information received by Transport Canberra and City Services (TCCS) on 2 February 2024. It is my understanding that you are seeking access to the following government information:

All traffic studies assessments reports concerning the following roads in the ACT from 2019 to present:

- a) Southern Cross Drive
- b) Beaurepaire Crescent, Holt
- c) Pickworth Street, Holt

Timeframes

A decision is due on your access application by 18 March 2024.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the FOI Act.

Decision on access

In accordance with the FOI Act, a search of TCCS records has been completed and records relevant to your request have been identified.

Some of the information falling in scope of your application is identified to be traffic control data and is not currently captured in a report. Access to traffic control data is available by application to Roads ACT. A description on this service is available here (Provision of Traffic Control Data) and the application can be made to Edward.Meredith@act.gov.au. In accordance with section 45(g) of the FOI Act, I am refusing to deal with your application where it applies to these records as the information is already available for purchase. Below is a list of surveys that have been undertaken since 2019:

- Southern Cross Drive: Last surveyed in 2022 with data collected from three locations.
- Beaurepaire Crescent, Holt: Last surveyed in 2019 and 2023 with data from three locations.
- Pickworth Street, Holt: Last surveyed in 2020 with data collected from three locations.

Upon reviewing the remaining two records and applying the public interest test under section 17 of the FOI Act, I have found it to be in the public interest to provide you with full access. The reasons for my decision are detailed below in the statement of reasons.

Statement of Reasons

In making my decision on disclosing the relevant government information, I must identify all relevant factors in schedule 1 and 2 of the FOI Act and determine, on balance, where the public interest lies. I have taken the following into account:

- The FOI Act; and
- The Human Rights Act 2016.

Schedule 1:

• No relevant sections identified.

Schedule 2:

Factors favouring disclosure (Schedule 2.1)

- Schedule 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability.
- Schedule 2.1(a)(iv) ensure effective oversight of expenditure of public funds;
- Schedule 2.1(a)(viii) reveal the reason for a government decision and any background or contextual information that informed the decision.

Factors favouring non-disclosure (Schedule 2.2)

• No relevant factors identified.

In reviewing the relevant record, I have identified that disclosure is likely to enhance government accountability and reveal reasons for a government decision. I have not identified information where factors favouring non-disclosure apply. I have found that disclosure is, on balance, in the public interest and provide you with full access to the records enclosed at Attachment B.

Charges

In accordance with <u>Freedom of Information (Fees) Determination 2018</u>, a fee of \$0.35 per page of information disclosed, except for the first 50 pages, may be applied to an access application. No fees are applicable to this application as the number of pages being released are within the fee-free threshold.

In accordance with section 28, your application, my decision and the information disclosed to you will be published within 3-10 business days. Ombudsman review

The requestor has noted there is a large no. of cars speeding and revving their engines on Beaurepaire St in Holt. There are currently no traffic calming or speed hump devices installed along the street.

Road Geometry and Layout

Two lanes undivided with several concrete refuge islands. Moving towards Starke Street there are several sections with a wide concrete median.

Surrounding Environment

Residential area – there is a small local shopping centre along this street.

Items to investigate on site:

- Signs of anti-social behaviour
- Motorist behaviours

Actions

- Engineering the traffic conditions have been investigated and there are recommended traffic management improvements that will be implemented under future programs when funding becomes available and subject to competing priorities.
- Enforcement Beaurepaire Crescent is already a listed location for mobile speed cameras.
- Enforcement refer issue to ACT Policing re. speeding and anti-social behaviours.

Response

My name is Lauren, I work with Roads ACT.

I'm calling in regard to your enquiry about Beaurepaire Crescent.

The current traffic conditions on Beaurepaire Crescent have been investigated and there are recommended traffic management improvements that will be implemented under our future programs when funding becomes available and subject to competing priorities. In the meantime, I am going to refer your enquiry onto ACT Policing regarding the speeding and anti-social motorist behaviours.

LE review

I have reviewed Matthew's notes and discussed with TMS managers the following decision:

- Although there isn't a priority crossing provided at this location, there is a staged crossing opportunity given the wide median. This allows pedestrians to navigate one road crossing at a time and provides a safe place to wait in the median.
- Given the nearby bus stops, provision of a zebra crossing at this location would not be feasible given the conflict with buses pulling up at or leaving the bus stops to drop off and pick up passengers.

A normal zebra crossing would probably suffice for this location. Analysis of speeds, pedestrian and vehicle counts would be advisable. Visibility should be excellent in either direction, and the median provides plenty of space for pedestrians, so even a zebra crossing may not be necessary. Unfortunately, the way the compliant is posed, it is in anticipation of something that has not actually happened yet.
