

Freedom of Information Request - Reference 23 - 134

I refer to your application for access to government information received by Transport Canberra and City Services (TCCS) on 13 November 2023 seeking the following government information under the *Freedom of Information Act 2016 (the Act)*:

"...details of the total number of infringement notices that have been served for Nuisance Dog Barking in the ACT, for the past 7 years of the Domestic Animal Act 2000. Further detail and breakdown would be desirable i.e. by year and suburb".

Timeframes

A decision on your access application was due on 4 January 2024. I thank you for agreeing to an extension to 18 January 2024.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the FOI Act.

Decision on access

In accordance with the FOI Act, a search of TCCS records has been completed and the number of nuisance notices issued have been identified. However, nuisance notices have not been broken down by reason (e.g. barking) as only the offence is recorded. A copy of the data has been inserted into this letter as follows:

No nuisance notices were issued in 2017, 2019 or 2022.

Upon reviewing the information and applying the public interest test under section 21 of the FOI Act, I have decided to provide you with full access to the data. The reasons for my decision are provided below under the heading 'statement of reasons'.

Statement of Reasons

In making my decision on disclosing government information, I must identify all relevant factors in schedule 1 of the FOI Act. I must also identify all relevant factors in schedule 2 of the FOI Act and determine, on balance, where the public interest lies.

In reaching my access decision, I have taken the following into account:

Schedule 1

• No relevant factors identified.

Schedule 2

Factors favouring disclosure in the public interest (Schedule 2, Section 2.1)

- Schedule 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability; and
- Schedule 2.1(a)(viii) reveal the reason for a government decision and any background or contextual information that informed the decision.

Factors favouring non-disclosure (Schedule 2, Section 2.2)

No relevant factors identified.

In reviewing the records, no factors favouring non-disclosure were identified. Therefore, I find disclosure, on balance, to be in the public interest and have inserted a copy of the data as outlined above.

Charges

No fee is applicable as the number of pages being released is within the fee-free threshold.

Online publishing – disclosure log

Under section 28 of the Act, TCCS maintains an online record of access applications called a disclosure log. Your access application and this notice of decision will be published on the disclosure log within 3-10 business days. Your personal information will be removed from these documents prior to publication in the TCCS Disclosure Log.

Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek an Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in TCCS' disclosure log or a longer period allowed by the Ombudsman.
